Heat Policy BTI

“If the temperature measured in the shade exceeds 33° at, or after 11.30am, play may be abandoned at the completion of the game in progress during Tuesday and Thursday Ladies competitions. The points for any incomplete or unplayed set will be shared. The match bonus points will be shared unless there is an outright winner at the time of abandonment.”

TUESDAY LADIES MIDWEEK

4 LADIES

Matches shall consist of eight (8) sets. 12-point tiebreak will be played at 5 games all.
Being: - Eight (8) sets of Ladies Doubles
Each player shall participate in four (4) sets.
No change of partners allowed after the commencement of a match. Each pair shall play the opposing pairs twice.

Suggested order of play:-

The Order of play in a match may be changed by agreement between the two (2) Captains.

Commencement Time of match is 9.30am

No more than three (3) minutes warm up time is allowed before commencement of the first set, and thereafter no more than three (3) minutes is to elapse between the conclusion of one set and the commencement of the next. No warm up time permitted after the second set.

Finishing time is 3.00pm. Complete the game in play, share points for incomplete sets. If both teams agree to play on past 3 pm all sets must be completed.

Home Team shall be the first mentioned in the draw. The home team is responsible for court hire and the provision of a minimum of two (2) new tennis balls of a brand approved by the Management Committee.

The server in the first set shall be decided on a toss and the service shall alternate in subsequent sets.

Set put on. The Visiting Team shall put on the first set and alternate sets

Claiming Forfeits: Teams who do not have a pair ready to play at the stipulated time must forfeit a set. On expiration of ten (10) minutes the second set can be claimed, and at intervals of ten (10) minutes subsequent sets can be claimed until the end of the fifth set, when the match can be claimed.

Result Cards must be completed and signed by both captains. It is the responsibility of the winning Team to forward the card to the Competition Secretary within 48 hours of the match being played.
