CONDITIONS OF ENTRY

1. The tournament will be conducted strictly within the rules of the game

- as produced by the International Tennis Federation and the regulations adopted by Tennis NSW except as altered by these conditions.
2. The tournament committee shall have the entire management of the event and reserves the right to refuse entries without explanation, reduce the length of matches in the event of inclement weather or cancel events where insufficient entries are received. Tournament Director has the discretion to alter these rules as necessary for the betterment of the tournament.
3. The Tennis Australia Code of Conduct and Dress Code will apply to all events. The committee reserves the right to disqualify any player whose conduct is deserving of such action.
4. In the event of a dispute, the decision of the referee is final.
5. Entry fees must accompany entries, which must be on the prescribed form and lodged with the Tournament Directors before 30 May 2008. Entry fees will not be refunded without satisfactory written request.
6. Competitors are limited to four (4) events, with a maximum two (2) singles or (2) doubles events in consecutive age groups. Doubles pairings must remain unchanged if entering two (2) doubles events.
7. Players entering doubles events without a partner will accept any partner allocated by the tournament committee. This condition does not impose any obligation on the committee to find a partner.
8. The tournament will commence on Saturday 7 June at 8 am. Play will continue on Sunday 8 June and Monday 9 June unless otherwise directed by the committee. Matches may be set down for night play.
9. All NSW entrants must be financial members of Tennis NSW, or TNSW membership fee must be paid in addition to the entry fee/s.
10. All competitors must be at the nominated courts to commence their match at the stated time, whatever the weather. Any competitor unable to commence a match when called upon to do so, may be disqualified and entry fee forfeited.
11. In accordance with the NSW Player Development Board resolution, losers may be required to Umpire as directed by the Tournament Committee or Referee.
12. Singles matches in the main draw will be best of three (3) tiebreak sets (except 10 & under and 12 & under which will be initial round robin format followed by knockout playoffs for both singles and doubles). Doubles matches will be "best of two" with super tie-break at one set all. First and second round singles losers consolation will be pro-set matches, tiebreak at 8-8 for preliminary rounds, best of three (3) sets for semis & finals. Where there are insufficient entries in an age for knockout – round robins will be played.
